

Three Oaks Cider® “Win 1 of 5 Three Oaks Cider Cinemas” Promotion Terms & Conditions

How to Enter Details:

To enter the chance to win 1 of 5 Three Oaks Cider® Cinema prize bundles, consumers must purchase a 10-pack of any Three Oaks Cider® product during the Promotional Period from any participating store; and enter by scanning the QR code on the in-store promotional material, answer the question “Tell us in 5 words or less your backyard cinema movie of choice,” take a photograph of your receipt, validate your age and complete the entry form details online. Entry is open to Australian residents aged 18 years and over.

Maximum one entry per person, per day.

The prize consists of 1 x Three Oaks Cider® Cinema prize bundles valued at \$705 (refer below for full prize details) delivered to a nominated address within Australia. 6. During the Promotional Period, the promotion will be conducted in participating alcohol retail stores displaying the competition details (“Participating Outlets”) on the dates outlined in clause 5 and only while stocks last.
